PROPOSAL TO WHICH THIS NOTICE RELATES:

Bunbury Outer Ring Road (Northern and Central Sections) Assessment No. 2215

Pursuant to section 43A of the *Environmental Protection Act 1986* (EP Act), the Environmental Protection Authority consents to the proponent making the following changes to the proposal during assessment without a revised proposal being referred -

Amendments to the design, construction and alignment of the proposal resulting in a 26 hectare (ha) decrease in the development envelope from 651 ha to 625 ha (refer Schedule 1).

1. The proponent may change the proposal as provided for in this notice.

RIGHTS OF APPEAL:

There are no rights of appeal under the EP Act in respect of this decision.

STATEMENT OF REASONS CONSENT TO CHANGE PROPOSAL DURING ASSESSMENT

Proposal: Bunbury Outer Ring Road (Northern and Central Sections)

Proponent: Main Roads WA

Decision

For the reasons outlined below, the EPA has determined to consent to the Proponent changing the Proposal outlined in Schedule 1, attached to this Statement of Reasons.

I have also determined that no consultation or public review is necessary when considering the request to consent to the change. This is due to the nature of the changes which would result in a decrease in the extent of the Proposal from that as described in the proponent's referral documentation. In addition, the proponent's supporting and additional information incorporating the changes will be published for a four-week public review period and the changes to the Proposal will be fully assessed in the EPA's Report and Recommendations to the Minister for Environment which will be subject to a two week appeal period.

Background

On 6 June 2019, Main Roads WA referred the Proposal to the Environmental Protection Authority (EPA) under section 38 of the *Environmental Protection Act 1986* (EP Act).

The Proposal is to construct and operate the northern section of the Bunbury Outer Ring Road (BORR) and upgrade the central section of the BORR. This includes 19 kilometres of freeway-standard dual carriageway, bridges, interchanges and other associated road infrastructure between Forrest Highway and Boyanup-Picton Road (northern section) and between Boyanup-Picton Road and South West Highway (central section).

The Proposal as referred included clearing of up to 119.3 hectares (ha) of native vegetation (including impacts to threatened ecological communities (TEC), three priority flora species and riparian vegetation). The Proposal as referred also included clearing of up to 104.7 ha of conservation significant species habitat and displacement of 49 western ringtail possums.

The EPA determined to assess the Proposal at the level of Referral Information with Additional Information (4 week public review) on 3 July 2019.




Figure 1: Development envelope showing proposed changes

In advance of the EPA preparing a report on the outcome of its assessment of the Proposal, the Proponent has sought the EPA's consent to the proponent changing the Proposal. The s43A change would result in a 26 ha decrease in the development envelope from 651 ha to 625 ha (Figure 1).

The proposed changes to the referred proposal decrease the extent of the development envelope during construction and operation. The primary reason for the change is to decrease the extent of the area of native vegetation and conservation significant species habitat within the development envelope potentially impacted by the proposal by considering alternative infrastructure design options.

Relevant Statutory and Administrative Provisions

Section 3.8 of the Environmental Impact Assessment (Part IV Divisions 1 and 2) Procedures Manual 2016 guides what information the EPA requires from a person wanting to change its proposal during assessment.

In considering the request for consent, the EPA considered the:

- details of the proposed change
- statement of the significance of the change
- rationale for the change.

Materials considered in making this decision

In determining whether to consent to the proponent changing the proposal the EPA has considered the following:

- 1. The document (EPA Assessment 2215, EPA Case CMS 17624): Request for Change to Proposal Under Section 43A of the Environmental Protection Act 1986 (WA), January 2020, Main Roads WA (Rev 1).
- 2. Spatial data provided by Main Roads WA showing the revised development envelope and revised flora and vegetation and conservation significant species habitat footprints.
- 3. Spatial data provided by the Main Roads WA at the time of referral showing the originally proposed development envelope and flora and vegetation and conservation significant species habitat footprints.
- 4. Supporting documentation for the proposal supplied by Main Roads WA at the time of referral: *Bunbury Outer Ring Road Northern and Central Sections EPA Environmental Referral Supporting Document,* May 2019, BORR Team (Rev 0).
- 5. The document Bunbury Outer Ring Road Northern and Central Sections Response to EPA Notice of Decision to Assess: Additional Information Requirements, 31 January 2020 (Rev 0, BORR-01-RP-EN-0009).

Consideration

1. Nature of the proposed change

The changes will result in an overall decrease in the extent of the development envelope from 651 ha to 625 ha. The key changes to the development envelope are decreases in the extent of the proposal at the intersections of Forrest Highway and Paris Road, the interchange at Raymond Road, and between the Boyanup-Picton Road and the southern South Western Highway interchanges. Minor increases in the extent of the development envelope are proposed at the northern intersection with the South Western Highway and at the South Western Highway near the Preston River.

As referred, the extent of native vegetation to be cleared was 119.3 ha. In the revised proposal, the extent of native vegetation proposed to be cleared has decreased to 92 ha.

As referred, the proposal will result in the clearing of up to 104.7 ha of conservation significant species habitat and displacement of up to 49 western ringtail possums. In the revised proposal, the area of conservation significant habitat to be cleared has decreased by 28.7 ha. The number of western ringtail possums estimated to be displaced has reduced by up to 24 individuals (from 49 to 25 individuals).

2. <u>Stage of the assessment process</u>

On 3 July 2019, the EPA set the level of assessment for the proposal as Referral Information with Additional Information (4 week public review). The EPA was awaiting the proponent's additional information when the request was made to change the proposal.

3. Currency, relevance and reliability of the information, including submissions

The proposal was referred to the EPA in June 2019 and all information submitted in support of the referral, not superseded by additional information, remains current, reliable and relevant. Additional information, as requested by the EPA was provided in February 2020.

4. Community engagement

The proponent has engaged widely with the community in relation to the original proposal, including engagement with government agencies and key stakeholders through 2017 and 2018 and targeted landholder consultation in 2017 and 2018. Four community information sessions were held in October 2018 and Main Roads WA provides regular updates on the proposal via their website. The proponent has continued to consult with stakeholders since referral of the proposal. The EPA is unaware whether the community has been engaged with regard to the proposed changes. The EPA intends to publish information on the proposed changes for public information as part of the assessment process.

5. Level of public concern

The EPA advertised the referral information for public comment from 14 June 2019 to 20 June 2019 (inclusive). Ninety eight comments were received during the public comment period, a high level of public interest at referral stage. The majority of public submissions requested the proposal be assessed at the level of public environmental review. The EPA does not consider that the proposed changes would result in an increased level of interest in the proposal.

Consideration of Whether the Change is Unlikely to Significantly Increase Any Impact that the Proposal May Have on the Environment

The following were considered:

a) <u>Values, sensitivity and the quality of the environment which is likely to be</u> impacted

Flora and Vegetation, Terrestrial Fauna, Terrestrial Environmental Quality, Inland Waters, Social Surroundings and Air Quality were considered to be preliminary key environmental factors at the time the Level of Assessment was determined. The proposed changes give no cause for additional environmental factors to be considered as the changes have the potential to impact on Flora and Vegetation and Terrestrial Fauna.

The majority of the changes will result in decreases in the potential impacts to the environmental values of native vegetation, conservation significant species habitat and western ringtail possum displacement.

b) Extent (intensity, duration, magnitude and geographic footprint) of the likely impacts

The proposed change to the development envelope is an overall decrease of 26 ha, from 651 ha to 625 ha.

The proposed changes include reductions and additions to the development envelope, with an overall decrease of 26 ha. The extent of the individual areas to be increased and decreased within the development envelope have not been provided by the proponent during this request for a change to the proposal. The proposed changes to the proposal will be included in the additional information requested by the EPA in July 2019 under s40(2)(a) of the *Environmental Protection Act 1986 (WA)*. The proposed changes will be considered during the assessment of the proposal by the EPA.

The reduction of the development envelope area includes decreases in the extent of clearing of native vegetation and conservation significant species habitat. For this reason, the EPA supports the additions to the development envelope, to provide an overall decrease on impacts to the native vegetation, conservation significant species habitat and western ringtail possums.

c) Consequence of the likely impacts (or change)

The consequences of the likely impacts of the proposed changes on native vegetation and conservation significant species habitat have decreased from those proposed in the original proposal.

d) <u>Resilience of the environment to cope with the impacts or change</u>

The majority of the changes to the development envelope will result in the avoidance of impacts to environmental values and will retain areas of native vegetation and conservation significant species habitat, maintaining the resilience of these areas. The EPA considers that the resilience of the environment to cope with the changed proposal remains unchanged from that of the original proposal, should it be implemented

- e) <u>Cumulative impacts with other projects</u> Cumulative impacts will be considered in the assessment of the changed proposal as they were to be considered during the assessment of the original proposal. The decreases in the extent of native vegetation and conservation significant species habitat to be cleared is unlikely to significantly change the cumulative impact at a local or regional scale.
- f) <u>Connections and interactions between parts of the environment to inform holistic view of impacts of the whole environment</u> A holistic assessment of the changed proposal will be undertaken during the assessment stage of the proposal. The changed proposal is not expected to result in a change in impact to the ecological function and values of the area compared to what it would be if the original proposal were to be implemented.
- g) <u>Level of confidence in the prediction of impacts and the success of proposed</u> <u>mitigation</u>

There is no change in the level of confidence in the predicted impacts or the success of proposed mitigation as a result of the changes.

 h) <u>Public interest about the likely effect of the proposal, if implemented, on the environment, and public information that informs the EPA's assessment</u> The EPA is of the opinion that public interest in the proposal will likely remain the same; that is, a high level of public interest and notes that the revised supporting document with additional information will be published for a four week public review period.
